Future Leadership in Ag Scholarship Program

The Nebraska Corn Growers Association will award five, \$2,000 scholarships to students entering their first OR second undergraduate year, pursuing a degree in an agriculture related field.

Scholarship Description:

- Scholarships are for one year; previous recipients may NOT reapply
- Scholarship will be applied directly to the student's school account following their presentation to the NeCGA board
- Scholarships will be awarded for the 2018-2019 school year

Applicant/Application Requirements:

- Applicant must be entering his/her first OR second undergraduate year at an accredited junior college, college, or university (current high school senior OR college freshman).
- Applicant must be pursuing an undergraduate degree in an agricultural, agribusiness, or an ag vocation field.
- Applicant must be an NeCGA member or son/daughter of an NeCGA member.
 - o *Employees and the families of employees of NeCGA are not eligible for the scholarship
- Applications must be postmarked by: March 30th, 2018

Your Application Packet Must Include:

- Completed application
- Current high school or college transcripts
- Proof you are seeking an undergraduate degree or certificate in agriculture, agribusiness, or an ag vocation field (acceptance letter may suffice)
- Two (2) letters of recommendation (one from a non-family member and one from a teacher, counselor, or advisor)
- Current resume
- 500 words or less on "Why I am pursuing an agriculture-related career."
- 250 words addressing the following question – "What are the three most important issues facing the agriculture industry today." Briefly explain each issue.

Notification:

- Recipients will be notified by phone and/or email in May 2018.
- Official announcement will be made at the next NeCGA Board Meeting and via press release.
- Money will be applied to student's accounts in December 2018.
- Awardees must give a short presentation OR submit a summary at the end of the fall 2018 semester to the NeCGA Board of Directors
 - o Presentation to include thoughts on 1st semester of the year, new insight into the ag industry, how the scholarship helped you in your degree pursuit
